PLEASE NOTE: If taking a course through another institution, please check with the institution to confirm their course meets the ADE requirement for Arizona and/or U.S. Constitution. It is highly recommended to complete the requirements before completing your ASU program to avoid a "Deficiency" on your teaching Certificate from ADE. This is important if you want to teach in a state other than Arizona because some states may not consider your certificate if there is a deficiency on it.

## **Concurrent Certificate and Degree Policies**

No more than 20% of the minimum credits required for the certificate may come from another institution.

## Below are scenarios involving concurrent programs:

Active student begins degree program and certificate simultaneously	Could share all certificate credits (except for the culminating event).
Active student begins degree program, then adds a certificate	Could share all certificate credits (except for the culminating event).
Active student begins a certificate, then adds a degree program	Could share all certificate credits (except for the culminating event).
Student completed degree program at ASU, then returns for a certificate	No more than 40% of coursework towards the requirements of a graduate certificate can be completed prior to admission to the certificate program.  40% of the credits required for the certificate can be shared from the degree program.
Student completed a certificate, then returns for a degree program	Could apply all credits from earned certificate (as long as all are ASU courses) to degree program under standard pre-admissions policies (within 3 years, B or better, etc.).
Active student begins multiple certificates, then adds a degree program	All overlapping degree credits and certificates credits could be shared.
Active student begins a degree program, then adds multiple certificates	All overlapping degree credits and certificates credits could be shared.

#### **Continuouse Enrollment**

Once admitted to a graduate degree program or graduate certificate program, you must be registered for a minimum of 1 credit hour during all phases of your graduate education. Registration for every fall semester and spring semester is required. Summer registration is required for students taking examinations, completing culminating experiences, conducting a doctoral prospectus, defending theses or dissertations or graduating from the degree program.
